

COP ESD CAREER & TECHNICAL EDUCATION (CTE) SURVEY

Executive Summary of Findings

April 2024

WHAT:

Banach, Banach & Cassidy, Inc. (BB&C) conducted an online survey related to Career & Technical Education (CTE) from April 14-30, 2024.

The survey was commissioned by COP ESD on behalf of the 10 local school districts in COP ESD's service area (Cheboygan, Otsego, and Presque Isle Counties).



THE SURVEY:

- The online survey was open to parents of schoolage children, school employees, and all other adult residents of Cheboygan, Otsego, and Presque Isle Counties.
- One-thousand-two hundred seven (1,207) individuals responded to the survey.



CTE COMMUNITY SURVEY FINDINGS

THE PURPOSE OF THE SURVEY WAS TO ACCESS:

- Public understanding of CTE programming
- Awareness of the need for CTE programming
- Opinions related to a proposal that would help students prepare for CTErelated employment opportunities
- The value of various educational options
- The level of support for a tax to support CTE program expansion


PUBLIC UNDERSTANDING OF CTE:



To assess the level of CTE
understanding in the 10 local
school districts served by COP
ESD, the questionnaire
opened with this question:

"In the past, CTE used to be known as vocational education. In addition to vocational classes, CTE now includes technology-related classes and emphasizes career preparation. Before this survey, did you know that CTE was formerly referred to as vocational education?"

There was even less awareness of CTE being formerly referred to as vocational education among parent respondents to the survey.

THE NEED TO Address cte Opportunities:

Survey respondents were asked about a proposal calling for local school districts and employers to explore ways of enhancing and expanding CTE program opportunities.

• This question was presented to survey respondents: "To address the shortage of workers who are trained for high-skill, high-wage jobs and careers, COP ESD is partnering with local school districts and employers to explore ways of enhancing and expanding CTE program opportunities for students in Cheboygan, Otsego, and Presque Isle Counties.

By supporting and partnering together on this COP ESD-led initiative, schools would serve as a conduit through which students and employers would connect to address CTE learning opportunities. T

The COP ESD-led initiative has widespread support because: It will expand and enhance CTE-related opportunities for area students. COP ESD will coordinate all CTE program opportunities to ensure program and financial efficiency across the three counties. All area school districts will host one or more CTE programs.

The CTE programs in each school district will be open to all students residing in Cheboygan, Otsego, and Presque Isle Counties. Employer partners will advise COP ESD and area school districts to help ensure that CTE-related opportunities continue matching workplace needs. By working together, all school districts will be able to offer more CTE program opportunities than any one school district could provide by working alone.



SUPPORT FOR A CTE-RELATED TAX PROPOSAL:

Most survey respondents agreed that enhancing and expanding CTE opportunities was a good idea.

Similarly, 69 percent of survey respondents answered the following question affirmatively:

Providing more CTE-related program opportunities for students may require asking homeowners to approve a tax increase of up to one mill. (A one mill increase would amount to less than 25¢ per day for the average homeowner in Cheboygan, Otsego, and Presque Isle Counties.) Based on what you know today, would you tend to be in favor or tend to be opposed to a tax increase of up to one mill?



Here are the top three responses of the 124 respondents who said they would tend to oppose a tax increase:




